There was one question as to whether the delinquent sludge customers had been cut off. Then the Mayor wanted to make sure we were charging a good fee for this service.

Commissioner Patterson moved to approve the consent agenda as presented, which was seconded by Mayor Pro Tempore Stiehler and the vote was unanimous.

7. Recognition of Achievement: Blakely Moore

Highlands School student Blakely Moore was recognized for becoming the 2015 1A Women's Cross Country State Champion.

8. Financial Matters: Budget Amendments

The Town received an insurance reimbursement for a lightning strike at the Sewer Plant, a donation for pool equipment from the Highlands Rotary Club and grant proceeds from the Governor's Crime Commission. Budget amendments are necessary to appropriate the funds.

Budget amendments needed are as follows:

- \$ 26,460 for the insurance reimbursement for the Sewer Plant
- \$ 12,075 for pool equipment donation from the Highlands Rotary
- \$ 10,838 for grant proceeds from the Governor's Crime Commission
- \$ 49,373 Total

Commissioner Patterson questioned if the reimbursement for the Sewer pump was what we paid out. Public Works Director Nix said it was an estimate of \$46,000 but this is the upfront cost and invoices would be provided for the rest once complete.

Commissioner Patterson made a motion to approve the budget amendments, which was seconded by Commissioner Pierson and the vote was unanimous.

9. Parks and Recreation Matters

A. Entegra Bank Property Transfer

Vice President, Terry Potts, was on hand to make the donation of the property on Pine Street that is included in the layout of Kelsey Hutchinson Founders Park that once housed the gazebo. A signed deed and plat were presented with this donation as well.

Mayor Pro Tempore Stiehler made a motion to accept the donation, which was seconded by Commissioner Patterson and the vote was unanimous.

B. Approval of Ballfield Fence Bids

Within the FY15/16 budget \$45,000.00 was budgeted for the Town Ball Field Backstop and Fence Replacement. Staff advertised for bids for this project October and two bids were received.

Asheville Contracting Co. dba Asheville Fence \$52,577.70 Franklin Fence \$43,212.00

Commissioner Patterson made a motion to award the ballfield fence bid to Franklin Fence at \$43,212.00, which was seconded by Commissioner Pierson and the vote was unanimous.

10. Planning Matters: Request for Public Hearing

The Highlands United Methodist Church has submitted their plans for the expansion of their fellowship hall. They received conditional approval to begin the conditional zoning process back in 2010 but never completed the process as they did not have all the property they needed at that time.

As such, they have submitted their plans and have begun the conditional zoning process and it will need to come before the board for your review and approval.

Staff would request that the board set a public hearing on this matter for the December 10th board meeting.

Commissioner Patterson made a motion to set a public hearing for the regular board of commissioner meeting on Thursday, December 10, 2015 at 7:00pm at the Highlands Community Building to review the Highlands United Methodist Church's request for conditional zoning, which was seconded by Commissioner Calloway and the vote was unanimous.

11. Miscellaneous Matters

A. Resolution Adoption: Macon County Animal Control Ordinance

Macon County handles animal control for Highlands. Recently, Macon County amended their animal control ordinance which shifted animal control to the Health Department.

As there have been changes to the ordinance they have requested that the town pass the enclosed resolution.

Commissioner Stiehler said after an accident they had at the club several years ago he was not in favor.

Commissioner Calloway said he would like to see the town not scrape the road unless someone who lives over there calls and requests it scraped.

After a few more brief comments, Commissioner Dotson made a motion that Monkey Hill not be plowed during times of snow unless year round residents request it, which was seconded by Commissioner Calloway and the vote was 4 to 1. Mayor Pro Tempore Stiehler voted nay.

12. Closed Session: Pursuant to NCGS §143.318.11(a)(6) Personnel

Commissioner Pierson made a motion to go into Closed Session pursuant to NCGS §143-318.11(a)(6) at 7:49pm to discuss a personnel matter, which was seconded by Commissioner Calloway and the vote was unanimous. Once discussion was held, Commissioner Pierson moved the Board back into open session at 8:55pm, which was seconded by Commissioner Calloway and the vote was unanimous.
