### 1. Meeting Called to Order

#### 2. Adjust and Approve the Agenda

Commissioner Patterson made a motion to approve the agenda as presented, which was seconded by Commissioner Stiehler and the vote was unanimous.

## 3. Approval of Fiber Construction Engineering Contract

MIS/GIS Director Matt Shuler stated the Contract presented is the same one that's been reviewed previously, but the approval today will allow them to begin work today.

Commissioner Patterson asked Shuler if his crew would be working with them and Shuler stated they will be, but initially, they will begin auditing the poles themselves.

Shuler stated they acted like they would be finished in two months then the bid process can begin. Shuler stated the LGC requires the actual bid to begin loan process but Wide Open will solicit the bidders and handle all of that, much like McGill does for the water tanks.

Commissioner Patterson made a motion to approve the Contract for Wide Open to do Route Hardening, Field Data Collection and CADD Construction Drawing, as presented, which was seconded by Commissioner Dotson and the vote was unanimous.

#### 4. Budget Amendment for Fiber Construction Engineering

Finance Director Rebecca Shuler stated she added a \$3,200 buffer to the 60% to cover any extra costs until the end of the year, because we expect 60% of the project to be completed in this fiscal year.
